SUMMARY AND OVERVIEW

Members will note from the details of these accounts **that there is a deficit of £4,953.50 for the year in question.** This is less of a deficit than predicted in January 2019 by £2,991.91.

The main reason for this is less expenditure than projected under the following headings: Salt Bins (-£1500) Translation Costs (-£963.98) Skateboard Park (-£200) Member's Training (-£150) Adverts (-£100) (Miscellaneoaus (-£77.93)

Please note however that some other headings slightly exceeded projected expenditure: Donations Bank Charges VAT

In relation to the Free Library Trust, there will also be a need for the Council to support the Building by way of contributions to the Building's independent Capital and Revenue Fund

NOTES TO THE ACCOUNTS
