SUMMARY AND OVERVIEW

Members will note from the details of these accounts that there is a surplus of £2,763.64 for the year in question. The main reason for this is less expenditure than projected under the headings: Donations Coed Ffynnon Fair Translation Costs Mayorial Fund Administration

In addition, miscellaneous income was received on behalf of the Free Library during the year.
